EUROPEAN COMMUNITIES (MARKETING OF FRUIT PLANT  
PROPAGATING MATERIAL) (AMENDMENT) REGULATIONS 2025

I, MARTIN HEYDON, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive (EU) 2025/145 of 29 January 2025<sup>1</sup>, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Marketing of Fruit Plant Propagating Material) (Amendment) Regulations 2025.

2. The European Communities (Marketing of Fruit Plant Propagating Material) Regulations 2011 (S.I. No. 384 of 2011) are amended in Regulation 2(1) by substituting for the definition of “Directive”, the following –

“‘Directive’ means Council Directive 2008/90/EC of 29 September 2008<sup>2</sup> (as amended by Regulation (EU) No 652/2014 of the European Parliament and of the Council of 15 May 2014<sup>3</sup>, Commission Implementing Decision (EU) 2016/159 of 4 February 2016<sup>4</sup>, Commission Implementing Decision (EU) 2016/1887 of 24 October 2016<sup>5</sup>, Commission Implementing Decision (EU) 2019/120 of 24 January 2019<sup>6</sup> and Commission Implementing Decision (EU) 2022/1933 of 12 October 2022<sup>7</sup>), Commission Implementing Directive 2014/96/EU of 15 October 2014<sup>8</sup> (as amended by Commission Implementing Directive (EU) 2019/1813 of 29 October 2019<sup>9</sup>), Commission Implementing Directive 2014/97/EU of 15 October 2014<sup>10</sup> and Commission Implementing Directive 2014/98/EU of 15 October 2014<sup>11</sup> (as amended by Commission Directive (EU) 2020/177 of 11 February 2020<sup>12</sup>, Commission Implementing Directive (EU) 2022/2438 of 12 December 2022<sup>13</sup> and Commission Implementing Directive (EU) 2025/145 of 29 January 2025);”.

These Regulations update existing Legislation with regard to the minimum quality standards and controls on the marketing within the European Union of fruit plant propagating material and fruit plants intended for fruit production.
