## INDUSTRIAL TRAINING (RETAIL INDUSTRY) ORDER 2018

An tSeirbhís Oideachais Leanúnaigh agus Scileanna, after making such inquiries as it thinks proper and consultation with organisations and associations appearing to it to be representative of substantial numbers of employers in the activities referred to in this Order and of substantial numbers of persons employed in such activities, in exercise of the powers conferred on it by section 23 of the Industrial Training Act 1967 (No. 5 of 1967) and by section 38 of the Further Education and Training Act 2013 (No. 25 of 2013) hereby makes the following Order:

1. This Order may be cited as the Industrial Training (Retail Industry) Order 2018.

2. The following activities are hereby declared to be designated industrial activities for the purposes of the Industrial Training Act 1967 (No. 5 of 1967):

- (a) the making and supporting of sales to customers in a retail outlet;
- (b) the management of security and stock display in a retail outlet;
- (c) the control of stock for sale in a retail outlet; and
- (d) the processing and resolution of complaints made by customers in a retail outlet.

3. In this Order:

“retail outlet” means a place in which, or an internet website from which, as the principal activity and in the normal course of business, goods are sold directly to the public, but does not include a place or an internet website which has as its principal activity the sale of food or beverages for consumption on the premises or the provision of services where the sale of goods is incidental or ancillary to the provision of services.
