(AMENDMENT) REGULATIONS 2020

I, Michael Creed, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) for the purpose of giving effect to Commission Implementing Directive (EU) 2020/177 of 11 February 2020<sup>1</sup>, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Marketing of Ornamental Plant Propagating Material and Ornamental Plants) (Amendment) Regulations 2020.

2. The European Communities (Marketing of Ornamental Plant Propagating Material and Ornamental Plants) Regulations 1994 (S.I. No. 161 of 1994) are amended in Regulation 2(1) by substituting for the definition of “Directive”, the following –
