INDUSTRIAL TRAINING (SOCIAL WORK INDUSTRY)
ORDER 2024

An tSeirbhís Oideachais Leanúnaigh agus Scileanna, after making such inquiries as it thinks proper and consultation with organisations and associations appearing to it to be representative of substantial numbers of employers in the activities referred to in this Order and of substantial numbers of persons employed in such activities and consultation with the appropriate competent authority or authorities in the State, in exercise of the powers conferred on it by section 23 of the Industrial Training Act 1967 (No. 5 of 1967) and by section 38 of the Further Education and Training Act 2013 (No. 25 of 2013) hereby makes the following Order:

1. This Order may be cited as the Industrial Training (Social Work Industry) Order 2024.

2. The following activities are hereby declared to be designated industrial activities for the purposes of the Industrial Training Act 1967 (No. 5 of 1967):

- (a) the conduct of social work assessments of risk and protective factors impacting the safety and welfare of children and adults;
- (b) the design, management, supervision and review of care and/or intervention plans;
- (c) the delivery of social work interventions for individuals, families and communities; and
- (d) the preparation of reports regarding the protection and welfare of children and adults at risk or in need of social services.

3. The provisions of this Order shall not apply to any activity of industry for which a separate industrial training order is, for the time being, in force.
