I, JACK CHAMBERS, Minister for Public Expenditure, National Development Plan Delivery and Reform, in exercise of the powers conferred on me by section 7(2) of the Protected Disclosures Act 2014 (No. 14 of 2014) (as adapted by the Public Expenditure and Reform (Alteration of Name of Department and Title of Minister) Order 2023 (S.I. No. 19 of 2023)), hereby order as follows:

1. This Order may be cited as the Protected Disclosures Act 2014 (Disclosure to Prescribed Persons) (Amendment) Order 2025.

2. The Schedule to the Protected Disclosures Act 2014 (Disclosures to Prescribed Persons) Order 2020 (S.I. No. 367 of 2020) is amended –
